Garage Sale time will be here sooner than you think. The annual Tioga Terrace Garage Sale will be held on Saturday, May 15th. This annual event is a great opportunity to clean out those overstuffed garages, attics, and basements. Every year people come from all over to participate in this annual event, bringing a little taste of big city traffic to our neighborhood. As in years past, TTCA will hire Tioga County Sheriff's Department Deputies to direct traffic, keep the peace, ensure orderly traffic flow, and provide safe access for emergency vehicles. Your Tioga Terrace Civic Association will also provide two porta-potties on Highland Drive between Frederick and Overbrook.

Day of the Sale

Traffic Flow: We are working with local officials to find ways to improve traffic flow. As in years past, parking on Frederick Drive and Glann Road will be limited to one side to facilitate one-way traffic on those roads. Additional restrictions may be in place based upon input from local officials. Directional signs will be placed on the affected streets the night before and removed after the event. Your cooperation is greatly appreciated. Finally, please give yourself a few extra minutes leaving and entering the Terrace on Garage Sale day.

Food Vendors: Food Vendors must have permits from the Town of Owego and are reminded that they must comply with permit conditions. The permit ONLY allows stops in the street for 10-15 minutes before moving on.

Food/Beverages: Food and beverages should be pre-packaged. Food handlers of non-pre-packaged items must have access to running water for hand washing. Be aware that the Tioga County Health Department may do spot inspections.

Due to escalating costs associated with organizing the Garage Sale, the TTCA will be conducting fundraising activities. This year, we will be selling maps of Tioga Terrace for a nominal cost. We will be selling advertising space on the back of the maps, listing the address and major categories or items for sale. Ads can be approximately 100 characters in length and will be sold for \$5 each, on a space available basis. From the President

Isn't it great to finally see friends and neighbors outside again?! Spring's such a busy time for many families in the Terrace. For your Civic Association, it's our busiest season of all. Preparations are well underway for the annual Garage Sale...followed closely by our annual door-to-door Membership Drive that provides the revenue for yet another year of TTCA programs and activities. In that regard, we have a concern that I need to share with you.

While preparing for the 2010 budget year, we determined that the insurance policy which protects the financial assets of the Association does not provide any liability protection for our Board members or our many other TTCA volunteers. Given the scope of our programs, and the lawsuit-happy society we seem to live in these days, the Board felt it essential that we address this situation. After much discussion, the Board decided to purchase additional insurance that will provide an adequate level of liability coverage for all of our volunteers. Unfortunately, this extra policy comes at a cost of \$900, which represents about 17% of our annual operating budget. As a result, we need to increase our annual membership "dues" by \$2, for a total of \$12 per household.

For years we've been able to keep dues at \$10, hold the line on expenses, and utilize other methods to generate extra income – including the use of paid ads in our newsletters. Even at \$12 a year, I hope most of you would agree that we still deliver a lot for your money.

Since 1961, the TTCA has been an important, positive force within our community and we intend to maintain that tradition. With this added liability coverage, we'll be able to continue our service to Terrace residents without putting our valued volunteers at personal financial risk. As always, thanks for your continued support.

DID YOU KNOW......LOCAL LAW FILING.....LOCAL LAW NO. 4.....

SECTION 1. 44-1 Purpose. The purpose of this chapter is to provide for a method of enforcement and collection against an owner of property or other responsible party who has endangered the public safety, health, or general welfare by failing to comply with any federal, state, general specific or local law or ordinance or any order of the Town Code Enforcement Officer or Building Inspector which requires said owner or responsible party to perform work, acts, or improvements upon property in the Town of Owego.

The Town Board of the Town of Owego has determined that it is in the interest of the public safety, health and general welfare of the residents of the Town that the Town be empowered to undertake such work, acts or improvements and to collect the costs in the same manner as a real property tax lien.

SECTION 2. 44-2 Enforcement. Whenever an owner of real property or other responsible party is required by any federal, state, general, specific or local law or ordinance or order of the Town Code Enforcement Officer or Building Inspector to make improvements, perform any work or to do any act on such property, and such owner or responsible party shall fail to

make the improvement or perform the work or act required, the Town may enter upon the premises and cause such improvement, work or act to be done on such property, when the public health, safety, or general welfare is endangered by the failure to act.

Marcellus Shale, Tioga Terrace, and You

As most of you know, the Southern Tier, including Tioga County, has become the focus of natural gas exploration. The Marcellus Shale and other formations beneath us are believed to be among the richest natural gas deposits in the U.S. Drilling advocates point to its potential for reducing America's dependence on foreign oil, minimizing the use of "dirtier" energy sources such as coal, creating jobs, and generating revenues for state and local governments and local landowners. At the same time, opponents point to a long list of economic, public health, environmental and societal concerns which have the potential to significantly alter the quality of life in Tioga County.

Some residents may be under the impression that these issues apply only to large-tract landowners in the rural countryside, and that drilling operations pose no concerns for Tioga Terrace. The fact is that the majority of the Terrace is surrounded by undeveloped land – some of which is suitable for drilling operations. Today, a single drilling site can bore multiple wells extending horizontally for miles, in any direction – including under the Terrace. In certain situations, natural gas can be extracted from your property through a NYS Department of Environmental Conservation (DEC) provision called "Compulsory Integration". Common local concerns include "wear and tear" on local roads due to heavy equipment and truck traffic, impact on water supply, and disposal of wastewater. It is important to note that well siting is not controlled by local zoning or permitting.

DEC is currently completing an Environmental Impact Statement (www.dec.ny.gov/energy/58440.html). Little in the way of drilling activities is expected until DEC completes the EIS and promulgates new regulations. In the meantime, energy companies are actively purchasing leases in anticipation of those regulations being issued. One thing remains quite clear: the Marcellus debate has become increasingly emotional and polarized.



The Civic Association does not claim expertise in these matters, and it's not our intention to take a formal position on the issues. We do, however, urge all Terrace residents to stay abreast of happenings on this topic. Public awareness and education, we believe, are critical to understanding the issues and making informed decisions. If you have strong opinions, we urge you to contact local, state, and federal elected officials.

Did You Know?

- -Horizontal drilling enables a single well to follow a seam of shale for several miles.
- -Hydraulic fracturing ("fracking") involves injecting millions of gallons of water and chemical solutions into the shale under high pressure to stimulate well production.

Natural gas burns cleaner than coal, producing about half the emissions for the same amount of energy.

Cabot Oil & Gas in Dimock (PA) Township paid more than \$200,000 in penalties for environmental violations in 2009.

Even sloped land can be used for drilling sites. Soil removed from uphill areas is used to build up lower areas, creating a level surface for drilling operations.

Among the major beneficiaries of natural gas drilling will be local governments that stand to gain from taxes, increased local business, and possibly royalties and lease payments from land they own.

A typical drilling site contains 6-8 separate wells, lasts 30-50 years, and may be refracked every 5 years.

Each well requires 5-7 million gallons of water, and about 600 truck visits, to develop and frack.

A typical "producing" well generates \$16 million in gas revenues over its lifetime.

The Marcellus is just one of five different deposits of natural gas beneath Tioga County.
